**Subject:** Future Discontinuation of LiftMaster® Model LC-36A (Non-monitored Light Curtain)  
**Product Impacted:** LiftMaster Commercial Door Operator Accessories for: Logic 5.0, Medium-Duty Logic, DDO/LJ/ATSW, HCTDCU, and FDO/FDC/FDCL

## LiftMaster Commercial Door Operator Dealers, Installers, and Distributors:

The supply of the LiftMaster Non-monitored Light Curtain, model LC-36A, will be discontinued in the near future. We will continue to sell these LC-36A Non-monitored Light Curtains until inventory is depleted. At current consumption rates, we anticipate that inventory will be available into the 4th quarter of 2022.

Immediately and in the future, LiftMaster offers the following alternative for LC-36A applications:

### LC36M Monitored Light Curtain:

- Please strongly consider the LC36M Monitored Light Curtain.
- The LC36M is very similar in performance to LC-36A but offers the advantage of being monitored to address UL requirements as a standalone primary entrapment protection device.
- LC36M addresses the predominant opportunity to take advantage of the 3-foot plane of the light curtain without requiring additional monitored entrapment protection, typically an additional photo eye. Simply mount the LC36M with the lowest beam being no higher than 6-inches above ground to meet UL requirements.
- **Note that there is a \$50 list price discount applied when the LC36M is ordered along with the Logic 5.0 (L5) or Medium-Duty Operator in place of the basic CPS-U photo eye. This has never been true for LC-36A.**
- For Logic 5.0 and HCTDCUL, a quantity of 2 LC36M Monitored Light Curtains may be employed. For Logic 5.0 operators, the CPS3CARD is required for this application.
- For the rare application where a photo eye (mounted low) and 2 sets of monitored light curtains are desired, Logic 5.0 does not have the ability to monitor 3 entrapment protection devices. Future LiftMaster operators, beyond Logic 5.0, will have that ability.
- The LC36M Monitored Light Curtain is compatible with the following LiftMaster operator families: Logic 5.0, Medium-Duty Logic, DDO8900W, LJ8900W/LJ8950W, ATSW, HPH1, HCTDCU, and FDO/FDC/FDCL.
